the overwhelmingly negative response for the proposal, the project is currently on hold.

We supported an intensive response to the High Speed Rail Environmental Report for the Palmdale to Burbank segment of the California High-Speed rail, and educated our members about the issue.

Currently we have been working with our Area Representatives Arthur Javadyan and Ricardo Flores on street and traffic matters on Peoria St., Wentworth St., Green Verdugo Road, La Canada Way and Sunland Blvd. We are grateful for the consistent response from our council office to help mitigate these issues.

SHPOA volunteers maintain the website, put out in-your-mailbox bi-monthly newsletters, and publish the Daily Fodder 5 days a week to keep the community current on local issues. Additionally SHPOA posts Lost-dog and Found-dog notices in the Daily Fodder. SHPOA advocates for Shadow Hills and equestrian interests with our City Council representatives and government officials on a regular basis.

AND, this year we are co-hosting The Barn Dance at The Stonehurst on November 9, 2024!!! (See Barn Dance announcement)

At the October meeting, the 2025 Election for the Officers for SHPOA was described as follows:

Section 3 of the SHPOA By-laws. Duties: Officers shall fulfill all the duties as described in this section and any additional duties described in the SHPOA Policies and Operating Procedures.

A. The President is the Chairperson of the Board and shall preside at all General Membership and Board Meetings and fulfill all other duties of the Office of President as described in the SHPOA Policies and Operating Procedures. The President shall be ex-officio member of all standing committees with the exception of the Nomination Committee. The President must be a previous SHPOA Board member.

B. The Vice President shall act as an aide to the President and, in the absence of the President, shall assume the duties of the President. The Vice President shall also be responsible for providing guest speakers at the SHPOA General Membership meetings and fulfill other duties as described in the SHPOA Policies and Operating Procedures manual.

C. The Executive Secretary shall keep records of all official documents and correspondence as

required by the Policies and Procedures. The Secretary shall maintain the SHPOA Policies and Procedures manual.

D. The Recording Secretary shall keep an accurate record of the proceedings of all General, Special and Board Meetings, keeping such records as required by the Policies and Procedures manual.

E. The Treasurer shall keep an accurate record of all SHPOA financial activities including, but not limited to, invoices, bank statements and a running log of SHPOA's financial status. The Treasurer must provide a financial report at each SHPOA meeting listing the current account status as well as the income and expenses of the prior accounting period, whether it be monthly, bi-monthly, quarterly, etc.

F. The Membership Director shall initiate a program to increase General Membership, encourage current Memberships in SHPOA and maintain a record of each Member as defined in the SHPOA Policies and Operating Procedures manual.

Best Friends Partnering With Los Angles Shelters

In 2012, Best Friends made a commitment with the Los Angeles Animal Services (LAAS) to bring LAAS to a status of No-Kill (defined as 90%+ life-saving status) with a No-Kill Los Angeles (NKLA) initiative. Since that time, Best Friends helped take our city shelters from a pet lifesaving rate of 57% in 2012 all the way to 91% in 2020. The city had the opportunity to sustainably secure those gains by retaining these proven pet-lifesaving no-kill policies. Despite recommendations from Best Friends and other NKLA Coalition members, pet lifesaving was deprioritized. Consequently, Los Angeles Animal Services has been in the news for overcrowding, safety issues, sanitation, poor customer service and other problems. Over the past year, Best Friends has extended a multi-million dollar comprehensive package providing immediate and on-going support to operations prioritizing staffing positions, training agency restructuring, public and staff safety, sanitation and continuing rescue partner support. Unfortunately, Best Friends most

recent offer collected dust in the Mayor's office for nine-and-a-half weeks while approximately 200 pets each week were dying in Los Angeles shelters. Although Best Friends has refocused its resources to shelters more committed to prioritizing life-saving and are more actively seeking support from Best Friends, they will continue to be an active and vocal agent for the change needed for the Los Angeles to reform the LAAS and to regain and sustain 90% no-kill. Best Friends is now working with NKLA partners to address an urgent need to move 500 dogs out of LAAS shelters and has committed \$250,000 to save the most at-risk dogs.

Problem vehicles on city streets can also be reported for expired tags. California law requires vehicles to be currently registered if they are driven, towed, stored, or parked on public roads or highways at any time during the registration period.

TAKE PHOTOS

Taking photos is very very helpful in getting service you need. Any time you can safely take a photo, try to do so. The City authorities often need the date and time that the photo was taken to prove the complaint and carry out remediation.

Often when we attach or email photos, the transfer of the photo strips off the time and date of when the photo itself was taken, and the digital info in the received email will show the date and time the photo was transferred instead of the time taken. So you provide the time and date in in one of two ways:

- You can download a free app (there are many; search "time stamp camera" in apps) to allow your photos to have the date and time showing right ON your photo. You can usually turn this app on and off.
- Select the photo out of your library and then swipe up on the photo itself, which brings up all the info about the photo as well as keeping the photo on top of the screen. Take a screenshot of that screen.



City Ordinances Related To Foodware And Foodware Accessories

The City of Los Angeles is a large consumer of goods and a producer of waste including consumption of food or beverage and use of its related Foodware and Foodware Accessories. This had led to the approval of three Ordinances each dealing with some aspect of the world of waste with the hope of bringing the City to a State of Zero Waste. The Los Angeles Neighborhood Council Sustainability Alliance supports the overall Draft Program as defined within the three Ordinances, however does recommend consideration of project alternative that would include two а additional upstream measures and removing some downstream measures. The recommended additional upstream measures would include prohibiting the sale of all products packaged in polyvinyl chloride (PVC) and polyvinylidene chloride (PVCDC) as well as prohibiting the new installation of artificial turf. Artificial turf contains hazardous PFAs (per- and polyfluoroalkyl) chemicals known as "forever chemicals" which are carcinogenic and contain endocrine disruptors, neurotoxins and microplastics. Runoff from artificial turf contaminates drinking water, rivers and oceans with PFAs and microplastics. The Environmental Protection Agency has reported that there is no safe level of PFAs. Additionally, artificial turf can reach temperatures that are 70 degrees higher than air temperature readily reaching up to 180 degrees or more which can create a heat island effect. Artificial turf is an impervious surface impeding groundwater recharge and increasing risk of flooding. It also "off-gasses" ethylene and methane thereby contributing to the climate crisis. Recommended downstream measures should include such things as prioritizing cleaner, safer and more sustainable solutions to plastic waste management by leaving out harmful black-bin facilities such as mixed material processing facilities (also known as "dirty materials recovery facilities" or dirty MRFs), advanced thermal technologies and non-combustion thermal technology facilities from the downstream measures. PVC and PVDC are both not recyclable and are toxic resulting in harmful exposures at every stage of their lifecycles. PVC in the waste stream causes problems regardless of where it ends up. PVC packaging can contaminate otherwise recyclable plastics leading to an entire bale of recyclable material like

polyethylene terephthalate (PET) being rejected for recycling or contaminating the finished recycled product if it is missed. Even PVC that does not go in the recycling stream has a drastic environmental impact. If being mixed with other garbage that may either be incinerated and thereby producing carcinogenic dioxins and furans or sent to landfills where the vinyl chloride contaminates landfill gas and releases harmful chemicals into the air and groundwater.

Historic Period Of The Tujunga Village – The American Period

In 1867, during the American Period, Pedro Ybarra was the first person to file a homestead, mining and water claim in the Big Tujunga Canyon area though very few did so because the region, in general, was a barren semi-arid desert. The land was nearly impassible with numerous deep washes, large rocks, cacti and thick undergrowth. But a few enterprising people did continue to come. In the 1870s, Rancho Ex-Mission San Fernando was acquired by George and Benjamin Porter and Charles MacLay who was to become a California State Senator. When this partnership dissolved, Senator MacClay took over some 56,000 acres of the north and northeasterly parts of the ranch. The first major steps toward local development began in 1874 when Charles MacClay founded the town of San Fernando. The Southern Pacific Railroad had just laid an extension there. About the same time, David W. Alexander acquired Rancho Tujunga. Development would now begin on the lands of that Rancho. Ownership of the Rancho would change hands a number of times. First to see development would be the eastern portion of the Rancho-today's Sunland-Tujunga which lay some 4 miles east of the old village. Later came the western portion of the old rancho, just east and north of what later came to be known as Stonehurst. In the 1870s, a number of settlers were living near present-day Foothill Blvd/210 Freeway on public land adjacent to the northern boundary of Rancho Tujunga. Completion of the railroad to San Fernando and the later tie-in with the main continental railroad system in 1876 along with changes to laws relative to the allocation of local water sources accelerated local development. New owners acquired several large tracts of the Tujunga Ranch. A boom during the years 1886-1888 resulted from the passage of the Wright Act which created irrigation districts which encouraged agricultural development. M.L. Wicks, a resident of Glendale, purchased and subdivided the land adjoining the MacClay Rancho (Cont'd)

which lies immediately southeast of the future Stonehurst. Stonehurst now boasts having a Wicks St. bordering Stonehurst Park. The notso-local local U.S. Post Office was established in Roscoe in 1887 (originally named the Roberts' Post Office and later the Sunland Post Office). The Tujunga School District was established in 1888 to today's Lake View Terrace. The San Gabriel Timber Reserve in the mountains north of the Tujunga Wash (today's Angeles National Forest) was established in 1892. This was the second Timber Reserve in the United States, the first in California.

Standing Reward For Copper Wire Theft Reports

On February 13, 2024, the City Council's Public Safety Committee reviewed a Motion presented by Councilmember Kevin DeLeon relative to copper wire theft and streetlight vandalism. We are all aware of the high incidence of streetlight copper wire theft and the resulting outages. We are talking about some 223,000 streetlights citywide. While the Bureau of Street Lighting has been aggressively tackling the backlog of repairs due to damage caused by copper wire theft and streetlight vandalism, it has also invested in preventative measures to protect streetlight infrastructure. However, despite significant investments in repairs and prevention by the City, copper wire theft and streetlight vandalism has still resulted in extended repair times forcing impacted residents to go for weeks without adequate streetlighting while repair crews are responding to outages all across the City. In the past, the City has established monetary reward programs for information leading to arrests and convictions for a wide variety of crimes effecting public welfare. While currently the City Council may authorize rewards for information leading to arrests for specific incidents of copper wire theft on a case-by-case basis, why not a standing reward program which would allow law enforcement to more efficiently solicit the public's help in dealing with this theft/vandalism issue? After consideration of the Motion and providing opportunity for public comment, the Committee recommended approval of the Motion with minor amendments. The City Council's Public Safety Committee recommended that the City Council instruct the Los Angeles Police Department, the City Attorney, the Bureau of Street Lighting and the City Clerk to prepare and present recommendations to establish a standing

reward offer program for information resulting in the identification, apprehension and conviction for copper wire theft and streetlight vandalism crimes and thefts of bronze plagues and statues that occur within the City, including how the reward program is to be administered and what the potential fiscal impacts may be. Additionally, instruct the LAPD and any departments that may offer assistance to prepare and present recommendations for the implementation of public service announcement campaign informing residents of a standing reward offer for information on copper wire theft, streetlight vandalism crimes and thefts of bronze plaques and/or statues. At the February 14, 2024 City Council meeting, the vote was 13 ayes to 2 nays to adopt the Committee's recommendations. Our Councilmember Monica Rodriguez was among the ayes, the two nays were Councilmember Eunisses Hernandez (CD1) and Councilmember Hugo Soto-Martinez (CD 13).





Making Goat Cheese is Simple!

If you'd like to try making your own goat cheese, here's a simple recipe:

Ingredients: Goat milk, Lemon juice or white vinegar, A pinch of salt

Instructions: Heat the goat milk to about 175°F (not boiling), Add the acid (lemon juice or vinegar) and let it sit for 10 minutes as the milk starts to curdle, Pour the curds through a cheesecloth and let them sit for 1-2 hours, Squeeze out any excess liquid, Transfer the curds to a bowl, add salt and any herbs you like, and enjoy your homemade goat cheese!
