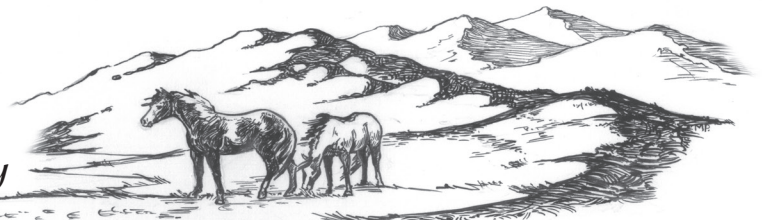

## Fighting High Speed Trains On Our Terms and Our Turf!

On Saturday, April 14th, more than 100 sign-waving residents and two dozen horses and riders attended an informative, intense and loud protest rally at Lake View Terrace Recreation Center, organized by the SAFE Coalition. The following communities were represented with speaking roles, showing the strength of the UNITED FRONT: Sylmar, Kagel Canyon, Lake View Terrace, Sunland-Tujunga, Riverwood Ranch, La Tuna Canyon, Shadow Hills, Stonehurst and Pacoima.

The two major themes were: first, the lack of respect shown by the high speed train Authority in scheduling its

board meeting downtown on a work day, rejecting more than 200 written requests from our community requesting the meeting be in a convenient, Valley location to foster greater community attendance and input. Second, speakers hit repeatedly on the weaknesses and damages posed by the existing route proposals (E1, E2 and SR14), the lack of integrity of the environmental studies, and the lack of funding available to finish the project in Southern California. Even the previously rejected "Metrolink Alternative," being re-assessed as a possible solution, was criticized as doing nothing to remove the present route alternatives.

We also emphasized the importance of communicating with our elected officials, in particular Senators Hertzberg and Portantino, in upcoming weeks as the public comment period for the 2018 Business Plan concludes and the Legislature will vote on whether to approve the Plan and enable continued funding. People in attendance felt strongly and chanted repeatedly that the Legislature should "elect to reject" the Business Plan. That chant and several others: "Let's Vote Again," "No More Trains," and "Bite the Bullet," resounded throughout the meeting! Our strong feeling is that the Business Plan is the sum of its parts and the Palmdale to Burbank project section is so flawed and infeasible that the entire Plan's credibility and worthiness is negated.

Finally, we noted for all in attendance that Mayor Garcetti, who is not working with or helping the SAFE Coalition or our communities, was in Iowa that day meeting with union members and farmers related to his run for President of the U.S., and Councilmember Rodriguez, who has ignored hundreds of meeting and support requests from the SAFE Coalition and our communities on this issue since taking office last July, continued to renege on her campaign promises and again missed this important and

## Shadow Hills Neighborhood Watch Update

In March, several Neighborhood Watch Block Captains and Senior Lead Officers Contreras and Livesey met to review issues in Shadow Hills.

### Crime

- Crime is down in our area by 50% from this time last year.

- Most crimes are property crimes, i.e., breaking into cars, vandalism, etc.

- Due to the rain, many homeless people leave their encampments and come into our area to steal items.

- LAPD is limited on what they can do re: arresting homeless/transients, including having them move the RVs or vehicles that they're living in.

### Illegal Vehicle Parking

- Official Police Garages (OPGs) do not want to impound RVs because there is no money in it for them. OPGs are impound yards that have lucrative contracts with the city. (Author's note: Because impound yards only make money when vehicle owners reclaim their vehicles, if no one reclaims their vehicle, the impound yard ends up as a non-compensated storage facility. After a set period of time, they are allowed to take title to the vehicle(s), and may either (1) keep the vehicle; or (2) sell/auction them off (including the contents). However, it is rare for a homeless person to reclaim their vehicle because it is very expensive (must pay the daily storage and other fees) and it is difficult for the impound yard owner to sell/auction it off because the condition of the RV is usually very poor. Because of this combination, OPGs do not want to be forced to impound them but are required to do so pursuant to their contract.)

### The Prosecution Process

- Taking videos/photos is extremely helpful to finding perpetrators — it's important to provide the videos to the police in a timely fashion because if a suspect is brought into the station for questioning, the police can only hold them for 48 hours. If they do not get corroborating evidence, they must release them. See below.

- It's very difficult to get suspects prosecuted due to the fact that they can only be held for 48 hours in order for the detectives to put together a convictable case (that's why it is important to get photos/videos submitted ASAP). The detective must present the case to the prosecutor who may or may not need additional evidence. This is complicated by the fact that the detective may or may not be able to re-arrest the suspect due to the suspect fleeing the area or other factors. About half of arrestees are released because a case cannot be put together in time. These people are experts on how to work the system.

### Speeding

- Sunland/Foothill's speed survey is now complete so once again motor vehicle operators can be issued speeding tickets. Typically, a speed survey on a street is taken to determine "safe" versus "unsafe" speeds. Once determined, if needed, new signage is mounted and a 30-day grace period commences. This grace period is provided



to allow time for frequent drivers of the affected street to "notice" the new posted speed limit.

### Signage

- Councilmember Rodriguez's office provided a city-approved printer and city-approved installer's name who can print/install new Neighborhood Watch signs to replace those that are in very poor condition. The cost will be about \$100 each and we are investigating various funding sources as the city will not pay for them. Initially, the LA Department of Transportation erroneously stated that local council offices can get their constituents free signs. Officer Contreras says lawn signs are also effective.

- A block captain mentioned that she would like to have signs like "Wildlife Corridor," and others posted in our area to remind people not to speed.

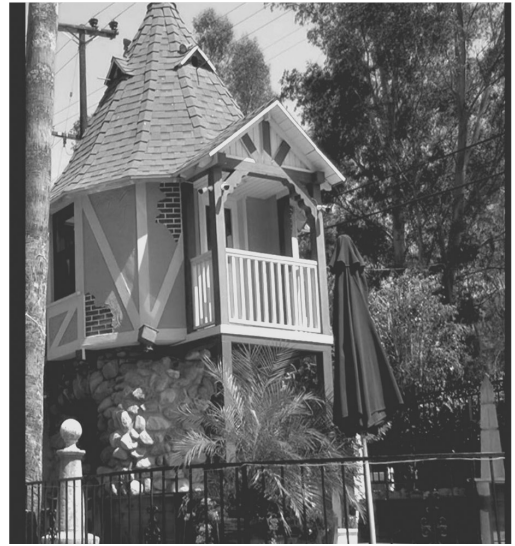
### Private Security

- One of our block captains reviewed hiring a private security patrol within Shadow Hills. For \$18,000 monthly, 24/7 armed patrols would be available to respond to suspicious activity and crimes for those residents who pay the monthly fee (fee would depend on how many households sign up for the contracted period). He has already set up an LLC to be the hiring company of a security patrol company. LAPD would still be in our area, too, so the private patrol would not replace LAPD.

## Motion to Secure Funding for Property Purchases in CD7 for Homeless Services Being Fast-Trackd

On April 11, 2018, Councilmember Rodriquez moved for a motion (File 18-0309) for the City to acquire property in the 7th Council District for the purpose of providing services to those facing the housing crisis.

The motion reads in part:

"An opportunity to acquire property has emerged in the 7th Council District, which could provide services to those facing the housing crisis. However, potential funding sources would need to be identified quickly in order to undertake a possible acquisition. The City should take action to ensure that the site is made available for a future affordable housing purpose."

The motion is ambiguous as it referred to property as "the site" and not "a site" for which she is seeking sources of funding for purchase. One could interpret this motion to mean that a site has been identified for purchase. It could also mean that no property has been specifically identified. Both scenarios will impact residents and businesses in CD7. Also, is the property to be used for providing "services" (i.e., mental health and social services) or for providing "housing" (permanent-supportive, bridge, emergency, etc.)?

Calls for clarification to the Councilmember's offices resulted in leaving a message and no return phone call was received.

This motion clearly was fast-tracked as it was introduced on April 11, 2018, the Housing Committee waived consideration on April 18, 2018 and it is scheduled for Council on April 20, 2018.

Now, assuming no parcel has been specifically identified for purchase, once again our communities are put into the position of being in the dark as to where the parcel is, and if it will impact their daily lives. I find myself driving around the area, seeing a vacant lot, and wondering if it is a contender for use as homeless housing and/or services.

Currently, the property located on Foothill in Lake View Terrace ("the bluffs") is in the early stages of development for permanent supportive housing led by Los Angeles Family Housing and is already owned by the City. This parcel has, not surprisingly, been met with opposition from residents. The difference is at least residents knew where the parcel was located based on a list of city-owned parcels issued years ago.

The urgency of Councilwoman's Motion is to request that the Chief Legislative Analyst, with the assistance of the Housing and Community Investment Department, and the City Administrative Officer, be instructed to identify, and present a report within approximately 15 days from April 11, 2018 on funding sources for property acquisition, including the possible use of CRA Bond Funds, New Generation Funds, Supportive Housing Loan Funds, Community Development Block Grants, and the HOME Investment Partnerships Program that may be used to purchase property in CD7.

The City has taken urgent and perhaps sometimes careless action over the last few years to build new affordable



housing, such as approving a new linkage fee, passing Proposition HHH, and approving new ordinances to facilitate construction. Another way the City can facilitate the construction of new housing is to identify and acquire key parcels for the purpose of affordable housing development, as had been done previously by the Community Redevelopment Agency.

Because all of these decisions affect stakeholders on multiple levels, it is imperative that our representative(s) engage with constituents concerning purchasing and/or developing parcels for uses that will impact our communities. If "the site" has been identified, or if it's just "a site-location to be determined," it is crucial that stakeholders are kept informed. We cannot tolerate any further "surprise" land use developments that affect our property values and daily lives. 🐾

## Creek Fire and Fond Land Preservation Foundation

Much vegetation and many trees in the Fond Park near the 210 Freeway entrance burned during the La Tuna Canyon Fire. Some of the eucalyptus trees in the portion of the park nearest to the Sunland Blvd. entrance to the 210 Freeway were so damaged that the fire department considered them to be in jeopardy of falling in the near future. We had those trees removed and we are monitoring the rest of the area. We are hopeful that some of the majestic oak trees will come back. In the next month or so we will hire an arborist to assess the condition of the remaining trees which suffered fire damage.

The fire did expose the landscape of the property. We will take this opportunity to clear debris which previously was not visible. One of the problems caused by the fire is the increased possibility of mud slides. Most of the danger is on the downslope portion towards La Tuna Canyon, most of which does not belong to the Fond Foundation. So far this year the rains have not caused severe flooding or mudflows, but those in potential flooding and mudflow areas should consider buying flood insurance.

There are two types of flood insurance: one is for damage to structures and the other is damage to the contents. Flood insurance is issued by the federal government and is not covered by your normal regular homeowners' insurance. Please contact your insurance agent who should be able to help with acquiring such a policy or policies. Applications for the Rebate Program began in December 2016 and as of April 2017, around 800 applications had been submitted. As we all know, street tree roots have been the primary cause of a majority of sidewalk damage. While the City makes every effort to retain our street trees, sidewalk repair is going to require some street tree removal. By the end of March 2017, the Bureau of Street Services had determined that about 35 street trees would need to be removed. The current City's Street Tree Removal Ordinance requires replacement of two trees for each "street tree" removed so we are looking at a requirement to replant 70 trees. It is the Rebate Program applicant that must file for the street tree removal permit and it is the Rebate Program applicant that is going to be held responsible for meeting the 2:1 tree replacement.

The City has graciously accepted the responsibility to plant one of these trees "off-site" which means somewhere in the City other than on the applicant's property, but the applicant will still have to plant one of the replacement trees "on-site" – that means somewhere on his/her own property at their own cost. At the time the incentive/rebate program was initiated, there was no budget to fund the City's tree replacement portion as promised.

Councilmember Mitch O'Farrell filed an amending Motion to that of the original Sidewalk Repair Ordinance to include a recommendation that City Council "Instruct the Bureau of Street Services to report with an accounting of trees expected to be impacted by the sidewalk repair incentive program and a budget request for the City to establish additional off-site trees as mandated by City policy". If the number of applications submitted were to continue at the same rate, it could be expected that about 2,400 applications could be filed by the end of FY 2016-2017 and if the same number of tree removal requirements were to continue at the same rate, there would be a removal of some 140 trees with the commensurate requirement to replace these with 280 street trees – half of which would need to be procured by, planted by and maintained/watered for a period of three years by the City.

City policy requires that replacement trees be a minimum 24-inch box size tree stock and must be watered once weekly for a minimum of three years. This planting can be performed by the City's Bureau of Street Services Urban Forestry Division or, let us hope, by one of the more responsible City's Plant non-profit partners. Regardless of whether the City or the non-profit procures and waters/monitors/maintains the trees for a period of three years, it is estimated to cost \$2,400/tree. By the way, for a private property owner to procure and plant the one tree that must be planted on-site on his own property is estimated to be about \$750 for that one 24" box size tree. For the City's part, if it continues to be responsible for replacing 140 trees annually, it would be looking at about \$336,000/year.

In an inter-departmental correspondence between the Bureau of Street Services and the City Council's Public Works and Budget and Finance Committees, the Bureau recommended that approximately \$336,000 be allocated annually for the City's portion of the Rebate Program's street tree replacement requirement throughout the 30-year Willits ADA lawsuit settlement term. ♣

## **Judge Rejects Neighbors' Appeal - Studio Project in Sun Valley Closer to Reality**

Several years ago the Studio Project, proposed to be built on Peoria Street near the intersection with Stonehurst, was first introduced to local community leaders in concept form. The appeal of an entertainment industry business in our area was strong and the project had many good features. Community leaders, including SHPOA, were hopeful the project would be developed in a way that proved to be an asset to the community. However, months later when project details became apparent, the height and proximity of the project to nearby residents presented serious concerns and began a long process of review and debate, both environmentally and legally.

Based on a recent court ruling, the long legal process has concluded and the project is likely to proceed. This is not the outcome the neighbors, SHPOA or our community were seeking. We felt changes should have been considered and made to make the project more acceptable given its close proximity to residential areas. In particular, we wanted the buffer distance between the Project and neighbors to be greater, and we wanted the heights of the proposed buildings to be lower. Given the project's "Hollywood" nature, there are special concessions, such as allowing extra height allowances, granted to the developer by the City that worked to the detriment of the community. The developer proved to be very stubborn and did not work with the community in good faith to improve the project. The neighbors most impacted by the project and the recent court ruling are very upset and rightly so.

During this multi-year process, these neighbors spent thousands of hours of time and tens of thousands of

dollars fighting for their rights. They bonded as a group, they raised money a variety of ways to support their case, and they turned out large numbers of people at meetings before the Planning Commission and others. Their effort is not in vain and they ought to be commended for exercising their rights. SHPOA was 100% opposed to the film studio once the new plans were made public, and submitted written comments, offered testimony at multiple public hearings/meetings, and contributed \$5,000 to the legal costs incurred by neighbors fighting the project.

Together with the impacted neighbors, we also fought with our elected officials over their positions on the project. While it was somewhat understandable that neighboring Councilmember Nury Martinez, representing CD6, would support the project as it was in her District, it was unexpected that our own Councilmember, Felipe Fuentes, would ignore his own constituents and support the project as well. That position by Fuentes created a permanent break in our relations with the Councilmember, and from that time forward SHPOA led widespread calls for his resignation...a result that was obtained in August 2016.

Again, while this is not the outcome desired, we commend the neighbors for the fight they organized and their determination through the arduous legal process. Now, we must make sure the "conditions" imposed on the project related to traffic, noise, lighting, security, etc. are implemented and enforced. This is not a good chapter in our relations with neighboring Sun Valley, which turned a deaf ear toward its neighbors, and did not support many of the compromises Shadow Hills proposed. We must be vigilant that this project does not serve as an unwelcome precedent for future development along the Sun Valley and Stonehurst/Shadow Hills border. 🐾
