Arthur Javadyan and Ricardo Flores, Deputies from Councilmember Rodriguez's Office (CD7) were also in attendance in order to answer city-related questions. Pizza was available to all.

Of major concern to the neighbors was the escalation of noise, traffic and houses being used as businesses in our residential zones - nuisance

houses. Deputy Javadyan explained the procedures needed to report said problems. The bottom line ... disruptive incidents must be reported in order for the city to take action. Every time! Dial MyLA311 to file a complaint. They will assign a confirmation number. To further the response, send the report with the confirmation number to Deputy Javadyan, along with any pictures and/or videos at arthur.javadyan@lacity.org or 818-352-3287. Remember: If it doesn't get reported, it didn't happen!

Following a long and sometimes heated discussion on nuisance houses, Susan Wong and Tina Eick gave an update on the status of Senate Bill 79 (SB79). The final update is included in the article "SB79 Update From United Neighbors" in this November newsletter.

Next, Tina Eick gave a brief update on SB9 legislation which allows higher density to our residential zones. SHPOA has asked Mayor Bass to exempt all areas in the City of LA that are designated Very High Fire Hazard Severity Zones from the SB9 legislation - including Shadow Hills. Currently, she has only exempted Pacific Palisades from SB9, which doesn't seem equitable. We have yet to hear from Mayor Bass' office.

The meeting was adjourned at 8:50 pm.



Remote Monitoring Of Streetlights Outages By Elektra Kruger, Resident

Over the past decade, the City has seen increasing incidents of vandalism against its streetlight network resulting in widespread outages and extended average repair times to restore lighting to any given location despite having launched a task force to address theft of copper wire from streetlight infrastructure, action having been taken against

recycling companies that purchase stolen materials in bulk and piloting newer technologies such as installation of solar-powered streetlights that do not require copper wiring and "smart nodes" on a small number of streetlights allowing the Bureau of Street Lighting to monitor the status of streetlights remotely. For the vast majority of streetlight outages, the City relies primarily on resident service requests to monitor the status of its network, a reliance that extends the time between when an outage occurs and when the City is able to make repairs whether simple or complex. Councilmember Heather Hutt believes that expansion of the City's capability to monitor the status of its streetlight network in real time would allow the City to respond to outages more swiftly and provide greater data on when and where damage to streetlights occur. The Bureau of Street Lighting should explore the feasibility of installing remote sensors on its streetlights whenever it is implementing other improvements reinforcing streetlight infrastructure. In late August 2025, the Councilmember presented a Motion to City Council asking that the Bureau be instructed to report with recommendations for embedding sensors within street lighting infrastructure to allow for more active monitoring of the status of streetlights when it is installing other security improvements. The Motion was referred to the City Council's Public Works Committee for their review and recommendations. At its September 10, 2025 meeting the Public Works Committee considered and approved the recommendations as stated in the Motion. The Los Feliz Neighborhood Council submitted a Community Impact Statement supporting the Motion. It is now up to the City Council to approve the Motion and instruct the Bureau of Street Lighting to prepare and present a report with recommendations for embedding sensors within streetlight infrastructure.

The Tujunga Wash Alluvial Sage Scrub
Habitat Vs A Golf Course

How many of you remember the days when there was a fight to protect the Tujunga Wash's unique and rare desert-like alluvial sage scrub habitat to the east of the Foothill Freeway from the commercial interests of a large water-

hungry 18-hole golf course. The alluvial sage scrub habitat is different from the scrub of inland deserts and hillside chaparral that Southern Californians generally recognize. The alluvial sage scrub habitat is a diverse collection of some 250 plant species dominated by scale broom, California buckwheat, yerba santa, pine goldenbush, desert juniper, cholla cactus and a federally listed endangered wildflower – the slender-horned spineflower with its nodding pink blossom that is so unlike any other plant that it has a genus all its own. The alluvial sage scrub loves everything most plants hate – barren terrain, rocky soil, endless sunlight, and catastrophic floods. To the untrained eye, the alluvial sage scrub habitat unlike the beauty of a forest habitat looks more like a stark lunar landscape. Despite the existence of the federally listed endangered flower on the property of the proposed golf course, by altering the proposed design of the golf course the limits of the Endangered Species Act were circumvented. By trimming off a few acres here and a few feet there, by leaving out artificially flood-controlling measures that would restrict nature's periodic shift of its waterways across the Wash, the Project ended up beyond the reach of federal agencies with the power to protect the Wash. That left the ultimate fate of the Wash to City Hall where standards for protecting endangered species are less strict. The developer called this a commonsense compromise that would attract dollars to Sunland. The U.S. Fish and Wildlife Service did however envision the endangered slender-horned spineflower as falling victim to this loophole. How many of you remember the floods of 2005. Many of our own properties suffered some manner of landslide damage. I remember a number of Shadow Hills residents gathering together to assist a resident to clean up mud debris gathered in their driveway

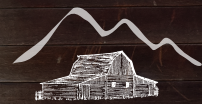

**Funding For A Sunland Park Off-Leash
Dog Park Project**

In late June, 2025, the General Manager of the Department of Recreation and Parks sought approval from the L.A. for Kids Steering Committee to submit a Work Plan requesting \$1,350,000 in Measure A Annual Allocation funding for a Sunland Park Off-Leash Dog Park. The Steering Committee referred the request to the City Councils Parks Committee, Community Enrichment Committee and Budget and Finance Committee. At their August 12, 2025

meeting, the Parks and Community Enrichment Committees took the L.A. for Kids Steering Committee's report relative to authorizing submission of a Work Plan for a Sunland Park Off-Leash Dog Park Project to the County of Los Angeles Regional Park and Open Space District under the Measure A Annual Allocation Program under consideration and approved the recommendations in the L.A. for Kids Steering Committee's report as follows:

- Authorize the Department of Recreation and Parks to submit a Work Plan to the County of Los Angeles Regional Park and Open Space District under Measure A Category 1 and 2 Annual Allocation Program for the Sunland Dog Park Project
- Authorize the General Manager of Recreation and Parks to accept the funds if awarded for the amount and scope of the Project subject to approval of the Mayor and City Council

Subsequently, the item was referred to the City Council's Budget and Finance Committee. At its September 2, 2025 meeting, the Budget and Finance Committee concurred with the findings of the Parks and Community Enrichment Committees. At its September 10, 2025 meeting the City Council adopted the item and now awaits approval of the Mayor.

because of the high volume of people simultaneously trying to leave their homes with limited egress routes available. In mid-January 2025, Councilmember Traci Parks presented a Resolution to the City Council stating that, by its adoption, the City of Los Angeles would include in its 2025-2026 State Legislative Program, support and/or sponsorship for any legislation that would result in amendments to the State's Density Bonus Law ensuring that evacuation routes within and immediately surrounding High Fire Severity Zones are not overwhelmed by dense development that could impede the safe passage of people fleeing life threatening circumstances. At its February 14, 2025 meeting, the City Council's Intergovernmental Relations Committee approved the Resolution as written and forwarded it to the full Council for its consideration. The Westside Neighborhood Council voted to support the Resolution advocating that the State not increase housing density where it would negatively impact evacuation routes. The Resolution was reviewed at the City Council's February 26, 2025 session. The City Council adopted the

When Your Bills Rise — And The Hydrants Run Dry By Carlos George, SHPOA Board

You open your monthly utility bill and there it is again: another increase in water and electricity rates. "It's inflation," they say. "Higher maintenance costs." But meanwhile, those same dollars aren't always reinvested where they are most needed — into the pipes, pumps, and reservoirs that keep fire hydrants working and water flowing uphill.

In Los Angeles, the Los Angeles Department of Water and Power (LADWP) is not only the city's utility provider. It's also one of the few agencies where funds get shifted into the city's general fund, rather than being fully dedicated to system upgrades and capital repairs. That means that money meant for your water infrastructure competes for budget space with other city priorities.

That arrangement creates a gulf between rising utility rates and deteriorating infrastructure. And when disaster strikes — as it did during the recent Palisades Fire — the consequences become stark: hydrants that ran dry, low water pressure, and a key reservoir that had been taken offline for repairs. Residents have sued, accusing LADWP and the city of failing to maintain critical systems. The Santa Ynez Reservoir, capable of

holding 117 million gallons, had been emptied for maintenance before the fire. The lawsuit claims this was a cost-saving choice, leaving the system dangerously underprepared.

LADWP responds that the hydrant failures were due to extreme demand and conditions outside what the system was designed to handle. They claim they met all fire code standards and that repairs were underway.

But the questions remain:

- Why allow funds to drift to the general fund instead of strictly into infrastructure?
- Who enforces that utility revenue is reinvested into water and power systems — not diverted?
- When hydrants fail during emergencies, who answers for it — the ratepayers, the utility, or the city?

For people in the hills, the costs of neglect show up not just in bills, but in their homes’ vulnerability. Meanwhile, ordinary citizens are left asking: Where is the accountability?



MyLA311 App Update By Carlos George, SHPOA Board

Following a major update to the MyLA311 app and website in March 2025, users and city staff have reported widespread issues:

Reported Problems

- Poor user experience: The new interface is harder to navigate.
- Unreliable AI features: The request categorization tool is causing errors.
- GPS errors: Service requests are being mislocated.
- Access issues: Field crews struggle to retrieve request notes.
- Missing history: Past service requests have disappeared.

- Premature closures: Requests are marked “closed” before work is done.
- Photo upload problems: Large images fail to upload properly.

City Response

In September 2025, the LA City Council ordered a full review of the system to:

- Compare performance pre- and post-update.
- Assess efficiency and cost savings.
- Collect feedback from staff and contractors.

Audit Reveals Millions Unaccounted for at Los Angeles Homeless Services Authority By Carlos George, SHPOA Board

Findings show weak oversight, missing documentation, and systemic failures in \$2.4 billion homelessness response

A comprehensive audit of the Los Angeles Homeless Services Authority (LAHSA) has uncovered widespread financial mismanagement, revealing that millions of taxpayer dollars cannot be fully tracked or verified. The findings, released jointly by city and county auditors and reviewed under a federal court order, cite “near-zero financial oversight” across multiple agencies responsible for managing homelessness funds.

Between 2016 and 2023, LAHSA advanced more than \$50.8 million to outside service providers. Auditors found that only \$2.5 million had been recovered, leaving \$8 million in

uncollected balances and \$5 million in expenditures without supporting documentation. Additional discrepancies in contract awards totaled over \$500,000.

The review also identified \$513 million in unspent or untracked homelessness funds citywide and found that approximately 25% of funded shelter beds remain unused, resulting in an estimated \$218 million in inefficiency costs over the past five years.

Auditors cited outdated data systems, poor documentation practices, and inconsistent contract monitoring as primary causes. The report also noted that LAHSA completed only two of eight planned internal audits in fiscal years 2023 and 2024, citing staff shortages and leadership turnover.

"This is not just an accounting issue — it's a question of trust," said City Controller Marisol Reyes. "Angelenos are being taxed to fight homelessness, and they deserve to know where every dollar goes."

The audit recommends the creation of a centralized oversight body for homelessness funding, mandatory repayment schedules for all cash advances, and the development of a unified data system connecting city, county, and LAHSA records.

Several City Council members have called for immediate hearings and potential restructuring of LAHSA's management. "The current system is broken," said Councilmember Dana Kim. "We must rebuild public confidence and ensure every dollar truly reaches those in need."

Despite the magnitude of the findings, no employees have been terminated, suspended, or charged in connection with the audit. Critics argue this underscores a deeper culture of impunity in Los Angeles' homelessness bureaucracy.

"No accountability, no consequences — and no arrests," said one civic watchdog. "Until there are real repercussions, these failures will continue to repeat themselves."

The full audit, including detailed findings and recommendations, is available through the Los Angeles County Auditor-Controller's Office and the U.S. District Court's Carter oversight report.
